Gift Aid Declaration
Maresfield Lawn Tennis Club (Charity no 1116960)

MLTC was granted Charity status in late 2006 which means that members may, at their absolute discretion, make an annual donation to the Club instead of a subscription, and the committee may, at their absolute discretion, accept such donations which qualify for Gift Aid, on which the Club can reclaim tax from the Inland Revenue, provided one of the following criteria is met :-

1. the adult member making the donation is him/herself a standard-rate taxpayer
2. a parent making the donation on behalf of a junior is him/herself a standard-rate taxpayer, even though that parent is not him/herself a member
3. an adult making the donation on behalf of an adult member who is a spouse, partner or a relative of that member is him/herself a standard-rate taxpayer, even though the person making the payment is not him/herself a member

If you meet one or other of these criteria, please complete the form below and return it as soon as possible to the Membership Secretary, thus allowing the Club to reclaim Gift Aid on your subscription/donation.

No further action will be required on your part; the Club will make a "blanket" application to the Inland Revenue, backed by individual forms received by us .
